# Four flagship initiatives



Expand to **60 European Universities with more than 500 universities by mid-2024**, with an Erasmus+ indicative budget totalling EUR 1.1 billion for 2021-2027.



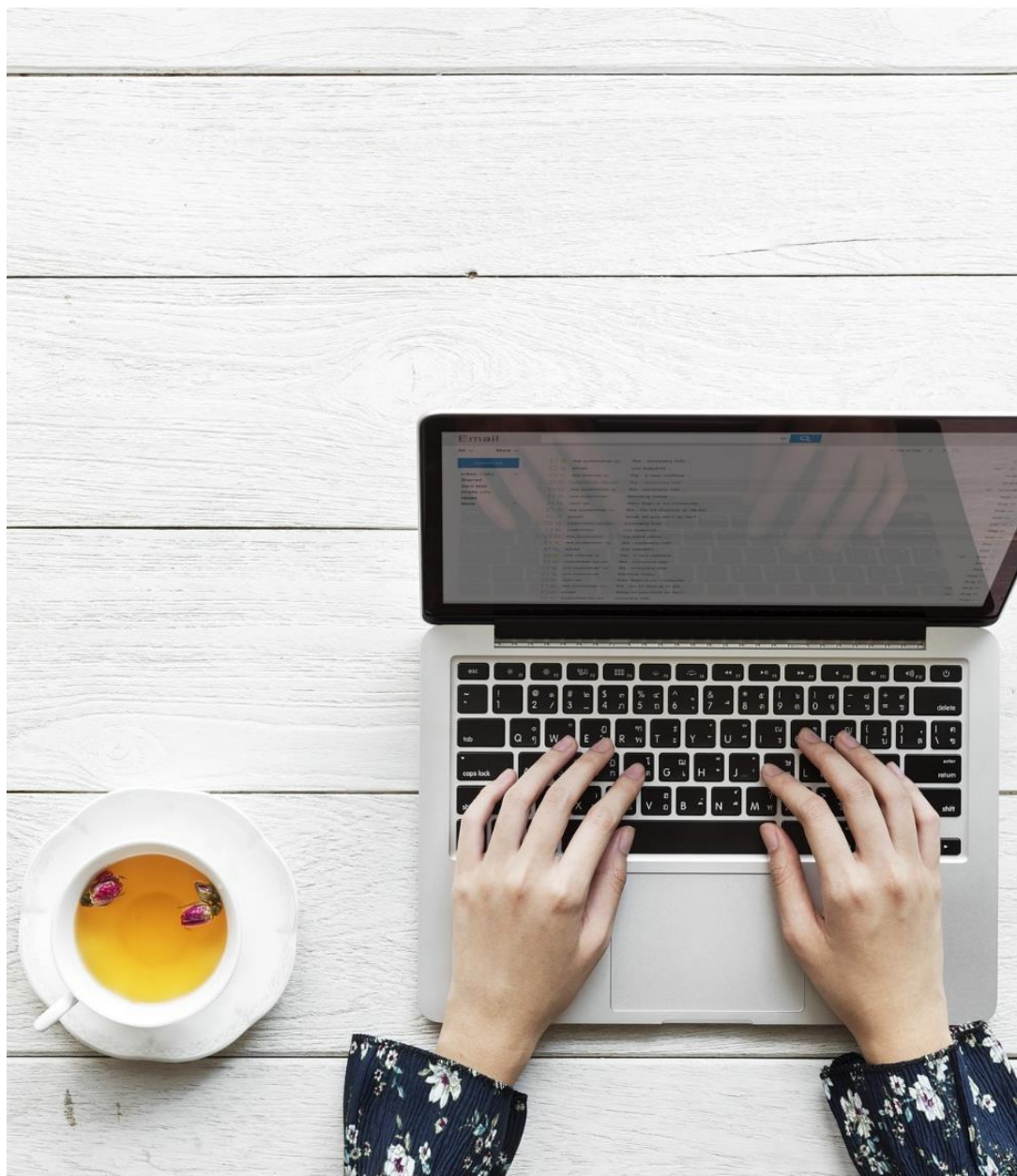
Work towards a **legal statute for alliances** of higher education institutions: pilot as of 2022 under Erasmus+ the implementation of existing European instruments



Examine options and necessary steps towards a **joint European degree**: pilot as of 2022 under Erasmus+ the first steps towards a joint European degree, in particular the development of European criteria for the award of a European Degree label



Scale up the **European Student Card initiative by starting deploying a unique European Student Identifier** to all mobile students in 2022 and to all students in universities in Europe by mid-2024



## How do we get there?

### Workstreams under European Student Card Initiative:

1. Connect all universities in E+ countries via a digital network - **Erasmus Without Paper (EWP) Network**
2. Offer a software for institutions without student information systems - **EWP Dashboard**
3. Offer a student facing infrastructure- **Erasmus+ App**
4. Issue an identifier to students to be able to identify them across IT systems - **European Student Identifier**
5. Ensure students can confirm their status abroad - **European Student Card**

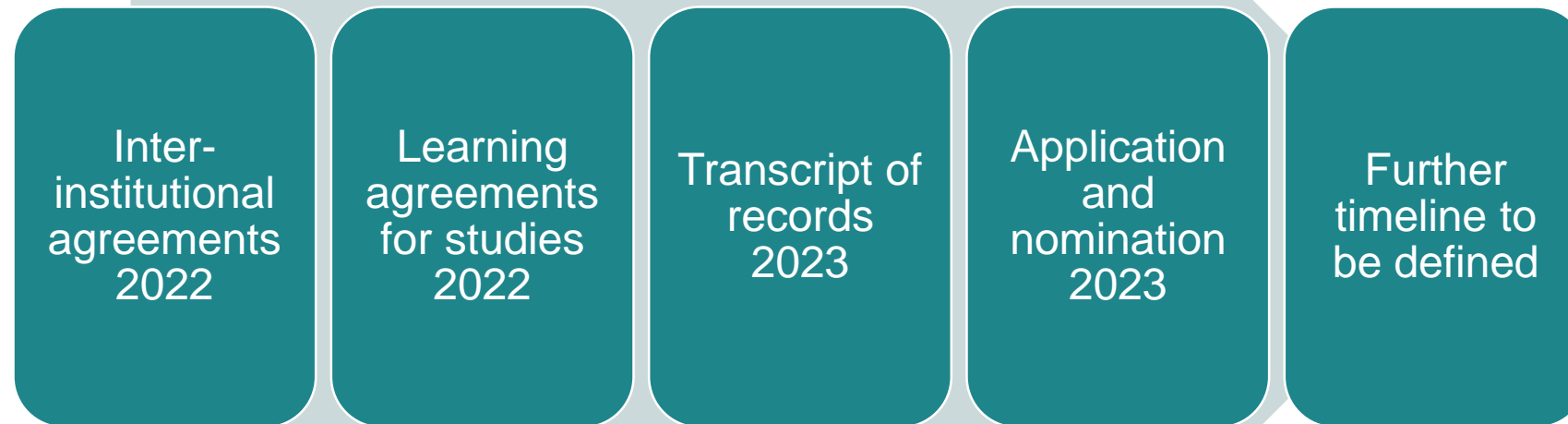
*Goal: Deploying European Student Card across EU*

**Under the condition that the systems are fit for purpose**



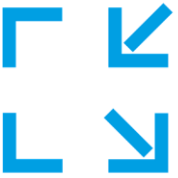


# Roadmap



- Academic year 2021/2022 has been considered as a **transitional year**
- This transitional year **is extended** until the end of the calendar year 2022 (31/12/2022)
- Calendar year 2023 **digital readiness** (which is part of the ECHE commitments) will become subject to a monitoring process by National Agencies.
- **ECHE monitoring guidelines** will be published by June 2022
- ECHE monitoring will **reflect the efforts** HEIs make in order to advance in the digitalization process – qualitative evaluation

# Clarifications of timeline of IIA



- Mobility flows in academic year 2022-2023 will need to be captured either by paper agreements or by “old” IIA versions from the previous programmes accompanied by email exchanges.
- HEIs are strongly encouraged to **exchange digital IIAs as soon as possible** (already for mobilities starting in fall 2022) and not to wait until 31/12/2022

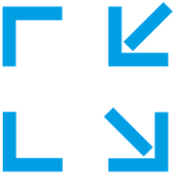


# Clarifications on LA



- **Consider year 2022 as a moment to switch to digital!**
- Efforts to be put in place to advance the digitalisation process of learning agreements
- Digitalisation of learning agreements advised already in fall 2022- in order to allow students to benefit from the Erasmus+ app features





# Interoperability of EWP

- The EWP+ Consortium is setting up a **Centralised Service Desk** to support HEIs
- The EWP+ consortium is putting in place a **governance structure** that will steer this process
- Within the current contract with EWP+ focus is being put on improving **interoperability between all systems** in EWP Network: Dashboard, software providers and in house systems.



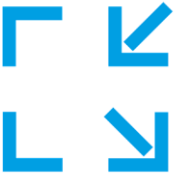
# What can you do in order to advance the digitalisation process?

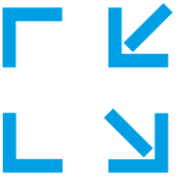


# Available features on the Erasmus+ App

# Future features of the Erasmus+ App



- Ability to manage administrative procedures for all students
- Expansion to more administrative processes
- Fully digital European Student Card
- Integration with Online Language Support
- Review of mobility experience, especially traineeships
- Much more...



# Your role in regards to the Erasmus+ app



- Populate the Erasmus+ app with information relevant to your HEI
- Urge students to use the app to connect to other students and obtain information about the mobility process
- Issue ESI so your students will be able to access the digital card on the app
